Linda Reil attended the meeting to discuss a property in Big Stone City. She had been working on purchasing this property however she has decided not to purchase it. Linda wanted the city to be aware of the situation.

The city received a residential complaint on the snow piles, the drainage and ice on his property. No action will be taken.

There will be a city wide election on April 9<sup>th</sup> for Mayor. The council will meet on Wednesday April 10<sup>th</sup> at 6:00 pm to canvass the votes.

Mayor Wiik expressed the cities appreciation to TJ Rabe, Robin Baerwaldt, and Brad Hanson. TJ has been on the council since October 2012. Before being on the council, he worked for the city at the Municipal liquor part-time starting in August 2001 and going full time in April 2008. Robin has been on the council since October 2009 and Brad joined the council in September 2003. Thank you for your hard work and dedication to the city.
