Motion to pay the presented claims was made by Hanson and seconded by Henderson. Voting in favor: Henderson, McMahon, Hanson, Rabe, Gulley, and Baerwaldt. Motion carried.

A motion was made by Gulley to approve the 2^{nd} reading of Ordinance 2017-06. Motion was seconded by Hanson. All in favor, motion carried.

Mr. Coester met with Verizon and presented a contract to the council. This contract is for an easement on the land by the BSC water tower. He is satisfied with the changes that were made and he recommends that the council approves this contract. After a lengthy discussion, a motion was made by Hanson to approve the Verizon contract. Motion was seconded by Baerwaldt. Voting in favor: Rabe, Baerwaldt, Gulley, Hanson, McMahon, and Henderson. Voting against: none. Motion carried.

A fire hydrant on private property was flushed be the owner of this property causing the water in the city to become rusty and unpleasant. Mr. Coester will send a letter expressing the council's concerns and recommend that a city employee be present when this hydrant is flushed.

A motion was made by Henderson to hold the 2018 election on April 10, 2018. Motion was seconded by Rabe. All in favor, motion carried.

The council discussed the available funds in the city checking account. Because of the Drinking water project, funds are low. There are several CD's that the city can cash if needed. A motion was made by Hanson to approve the cashing in CD 3368 which has a value of \$105,895.99. Motion was seconded by Gulley. Voting in favor: Rabe, Baerwaldt, Gulley,

Hanson, McMahon, and Henderson. Voting against: none. Motion carried. This CD will only be cashed if the Mayor and finance officer deem necessary.

The finance officer is interested in attending a class in Sioux Falls on February 2, 2018. The class is a training for LUCA and the 2020 Census. A motion was made by Henderson and seconded by Hanson to approve the finance officer attending this training. Voting in favor: Rabe, Baerwaldt, Gulley, Hanson, McMahon, and Henderson. Voting against: none. Motion carried.

The city will have an audit done for the years 2015-2017. A motion was made by Hanson to approve the hiring of Eide Bailly for this task. The motion was seconded by Gulley. Voting in favor: Rabe, Baerwaldt, Gulley, Hanson, McMahon, and Henderson. Voting against: none. Motion carried.

Being no further business a motion to adjourn the meeting was made by Gulley and seconded by Hanson. Motion carried.
