Roscoe made a motion to approve Uniform Alcoholic License for The Grocery Basket with TJ Rabe second. All in favor. Motion Carried.

Discussion was held on the electric rates and MRES suggested to raise rates 6% and if another adjustment needs to be made after the rate study is completed Council will determine that at a later date if need be.

Stoddard made a motion to increase electric rates 6% effective December 1, 2024 with Redfield second. Upon roll call: Ayes: TJ Rabe, Roscoe, Redfield, Stoddard. Naves: Hughes and Goergen. Motion Carried.

Office update consisted of the new IRS change in mileage reimbursement effective October 1, 2024. South Dakota Retirement. SDML workers compensation audit was filed and approved. The City will receive at 19% renewal credit of \$1,971.00. Discussion was held on the SDCL 34-4-103. After discussion Redfield made a motion to pass the following resolution with Hughes second. All in favor. Motion Carried.

RESOLUTION 2024-08 VIDEO LOTTERY

WHEREAS SDCL 35-4-103 Annual additional license fee for video lottery machines on licensed premises:

WHEREAS City of Big Stone City imposes a fee of \$50.00 for each lottery machine on the video licensed premises;

WHEREAS The fee imposed are in addition to fees imposed under SDCL 35-4-2 and 42-7A-41;

WHEREAS Shall be paid at the same time and in same manner as the fees paid in SDCL 35-4-2;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Big Stone City the fees will be effective January 1, 2025.
