Motion to pay the presented claims was made by Henderson and seconded by Hanson. Voting in favor: Athey, Hanson, Rabe, Gulley, Henderson and Baerwaldt. Motion carried.

New Business: Mary Smithwick from Big Rock Grill attended the council meeting to inquire about a liquor license for her business. She feels that serving liquor with meals would be an asset to her business. Currently, the city only allows one liquor license and that one is held by the city. A motion was made by Rabe to have Mr. Coester, the city attorney, look into to this subject and present his findings to the council at the next meeting. Motion was seconded by Henderson. All in favor, motion carried.

Randy Schmieg attended the meeting to discuss the traffic on the road by his house. He would like to see something done about the trucks entering the south driveway of the business. After a brief discussion, it was decided that the Mayor would discuss the issue with Officer Goergen.

For workers comp purposes, the city covers the volunteer fireman and summer rec volunteers. A motion was by Hanson and seconded by Rabe to approve this action. All in favor, motion carried. A complete list of volunteers for the city is available upon request at the city office.

The SDML Finance Officers School will be held June 8, 9, & 10, 2016 in Spearfish. A motion was made by Henderson to send the Finance Officer to the school. Motion was seconded by Gulley. Voting in favor: Baerwaldt, Gulley, Rabe, Hanson, Athey, and Henderson. Motion carried.

The city has been approached by two gentlemen interested in developing an area north of Chautauqua Park. They were inquiring on the city providing a road for this area. After a brief discussion, the council was reminded that other developers have been required to put the roads in and once the roads are up to the city's specs, the city will take over the roads and maintain them.

Missouri River Energy Services will host their Annual Meeting on May 11 & 12th. A motion was made by Gulley to have Bryan Austin the meeting. Motion was seconded by Henderson. Voting in favor: Baerwaldt, Gulley, Rabe, Hanson, Athey, & Henderson. Motion carried.

Old Business: The water contract with the City of Ortonville has been accepted and will be in effect until December 2017.

The city had received a maintenance supplemental service agreement from Missouri River Energy Services. This agreement pertains to any assistance provided from MRES for the

Electrical Department of the City of Big Stone. Mr. Coester is working with their attorneys and will update the council at the next meeting.
Being no further business a motion to adjourn the meeting was made by Gulley and seconded by Hanson. Motion carried.
