Motion to pay the presented claims was made by Gulley and seconded by Rabe. Voting in favor: Athey, Hanson, Rabe, Gulley, Henderson and Baerwaldt. Motion carried.

The terms of Councilmembers Baerwaldt, Athey and Gulley will expire this May. The Council approved the date of April 12th for the 2016 Election. Voting in favor by text message: Athey, Hanson, Rabe, Gulley, Henderson and Baerwaldt. Motion carried. Nominating petitions may be picked up at the city office beginning January 29. Deadline for filing a petition is February 26 at 5:00 p.m. The City will hold their election the same day as the school.

A motion was made by Gulley and seconded by Henderson to approve the following wages: Janelle Kelly – Library - \$12.60 per hour and Kelsey Nelsen – Liquor Store Cleaning - \$15.50 per hour. Voting in favor: Athey, Hanson, Rabe, Gulley, Henderson and Baerwaldt. Motion carried.

Steve Berkner, Ortonville's Mayor and Char Grossman attended the council meeting to discuss the Big Stone City/Ortonville Water agreement. The agreement will expire 12/31/2016. The City of Big Stone requested an extension for one year. They had presented the Big Stone Council with an agreement that would extend the contract and raise the rates among other changes. There were concerns and questions brought up by both sides. Steve and Char left the meeting at 8:10. Mayor Wiik updated the council on information from several different agencies concerning the water situation. She will contact Ortonville and set up a meeting for the water board.

The City currently has a loan with SD DENR. They have received confirmation from the DENR concerning the payoff of the loan. A motion was made by Henderson and seconded by Athey to make the final payment in the amount of \$235,501.29. Voting in favor: Rabe, Baerwaldt, Gulley, Athey, Hanson, & Henderson.

DeWane Stoddard, representing the Big Stone City & Rural Fire Department, presented the council with the department's 2015 annual report.

The City will be advertising for a 2016 Summer Rec Director and also for someone to run the concession stand at the ball field.

The Guard Unit from Milbank will be helping with a city wide cleanup. The cleanup will be May 14, 2016.

A motion was made by Gulley and seconded by Henderson to call a recess until Friday at 5:00 pm. All in favor, motion carried.

Mayor Wiik called the meeting back into session Friday, February 5, 2016 at 5:00 pm. Roll call: Athey, Rabe, Gulley, Henderson, & Baerwaldt. Absent: Hanson. Others present: Donna Van Hout, Robert Athey and Steve Berkner.

The water board met on Wednesday with the Ortonville water board. Mayor Berkner went over the outcome and presented the council with a new Water Purchase Agreement which would remain in effect until January 1, 2018. The water board had made several suggestions that the Ortonville Council did take into consideration and the new agreement does reflect these changes. Several options were discussed. Mayor Berkner left the meeting at 5:30.

After a lengthy discussion, a motion was made by Gulley to approve the Water Purchase Agreement with the City of Ortonville and the Water Plant Billing Dispute Agreement if several conditions have been met. Motion seconded by Athey. Voting in favor: Henderson, Rabe, Athey, Baerwaldt, & Gulley. Motion carried.

Being no further business a motion to adjourn the meeting was made by Baerwaldt and seconded by Rabe. Motion carried. Meeting adjourned at 6:00.
