Motion to pay the presented claims was made by Henderson and seconded by Hanson. Voting in favor: Athey, Hanson, Rabe, Henderson and Baerwaldt. Motion carried.

John McFarlane and Josh Wollschlager attended the meeting to discuss the City's current Ordinance on Sunday beer sales. It states beer cannot be sold before 11:00 am on Sundays. The State statue allows beer sales from 7:00 am to 2:00 am on Sundays. After a brief discussion, a motion was made by Henderson to make an amendment to the current ordinance changing the time of Sunday beer sales to follow the State Statue allowing the sale of malt beverages to start at 7:00 am and will end at 12:00 midnight. Motion was seconded by Hanson. Voting in favor: Henderson, McMahon, Hanson and Rabe. Voting against: Baerwaldt. Motion carried. After the new ordinance is read twice and published, a copy will be mailed to businesses with a malt beverage license in the City of Big Stone.

Wade Van Dover attended the meeting to update the council on the property Big Stone Therapies owns in Big Stone City. They will be moving some of their staff over to Big Stone City office. The council congratulated Wade on the success of Big Stone Therapies and welcomes them to Big Stone.

The third test well was not dug because of equipment problems. It will be dug in the next two to three weeks.

The US Department of Labor updated their salary threshold and this will affect three of the city employees. The final rule raises the salary threshold from \$455 a week (\$23,660 for a full-year worker) to \$913 a week (\$47,476 for a full-year worker) effective December 1, 2016. Mr. Coester explained to the council who would be affected and why. He recommended the three employees be changed to an hourly rate. A motion was made by Henderson and seconded by Baerwaldt to change the Finance Officer position, the Municipal Liquor Store Manager position and the Municipal Liquor Store full time position from salaried positions to hourly positions. Voting in favor: Rabe, Baerwaldt, Hanson, McMahon and Henderson. Motion carried.

Being no further business a motion to adjourn the meeting was made by Baerwaldt and seconded by Hanson. Motion carried.
