Jim Lusk, Jr. attended the meeting to address the council about his property on the corner of Tioga Street and Mitchell Avenue. He would like to vacate the alley that runs on the west side of his property. The City attorney went through the steps he would need to take to accomplish this.

Councilman Gulley updated the council on information he had on the test wells that were drilled in the city. He also had prices on some of the equipment that will be needed. The Council had voted previously to do three test wells and have had two test wells done. Utility Manager Athey will set up the third test well.

The second reading of the 2017 Appropriation Ordinance was held. A motion was made by Baerwaldt and seconded by Henderson to approve the second reading of **Ordinance No. 2017-01, "2017 Appropriation Ordinance"**. Voting in favor: Henderson, Hanson, Rabe, and Gulley. Motion carried.

Utility Manager Athey updated the council on purchasing a trailer for the utility departments and work that needs to be done on the lift stations. He will be hiring someone to do some repairs.
