Motion to pay the presented claims was made by Henderson and seconded by Rabe. Voting in favor: Henderson, McMahon, Hanson, Rabe, Gulley, and Baerwaldt. Motion carried.

Mary Hillman attended the meeting representing the Big Stone Lake Area Chamber. Mary addressed the council on the benefits of being a member of the Chamber. She also addressed concerns brought up by the Council. She will get back to the Council with a rate for the City.

Steve Weber updated the Council on the BSC Fire Department. Steve is the Assistant Fire Chief, Joe Wiik is the Chief, Chis Folk is the Treasurer and Blake Schmieg is the Secretary. The fire department ordered a new truck. It should be ready for delivery in August. They have a fund for the new truck and will be needing some assistance to cover the cost. Several local businesses will be contributing and they would like the City to contribute the remaining amount need to pay for the truck. No action was taken.

Water update: The City is waiting to hear back from Rural Water on the contract.

A motion was made by Gulley to table the Ulteig Engineering Services. Motion was seconded by Henderson. All in favor, motion carried.

A motion was made by Henderson to pay for a 2011 Ford F250SD XL Supercab 4WD for the Electric Department. Motion was seconded by Gulley. Voting in favor: Henderson, McMahon, Hanson, Rabe, Gulley, and Baerwaldt. Motion carried. The truck was won on bid from Montana-Dakota Utilities Co. in Billings MT. The Council discussed different options on getting the truck to Big Stone. A motion was made by Henderson and seconded by Hanson to have two people drive out to retrieve the truck. Voting if favor: Henderson, McMahon, Hanson, Rabe, Gulley, and Baerwaldt. Motion carried.

Mayor Wiik updated the Council on the South Dakota Municipal League District Meeting that will be held in Big Stone on March 21st. The City of Big Stone will be hosting the meeting and will be highlighting the many businesses in the area. She encouraged the Council to attend.

Being no further business a motion to adjourn the meeting was made by Hanson and seconded by Baerwaldt. All in favor, motion carried.
